### Question 1:

- “regarding the project, please clarify below question:  
1. if a Chinese bidder is allowed to participate and awarded this tender?  
2. if submitting bid via email address is acceptable??”*

### Answer 1:

1. As per Section 3 clause 4 of the bidding documents, *“Bidders who are eligible to participate in this tender are natural or legal persons (of public or private law) or joint ventures of natural or/and legal persons, which are legally established in Cyprus or in another European Union (EU) Member State or the European Economic Area (EEA) or third countries that have signed and ratified the plurilateral Agreement on Government Procurement (GPA) or have signed and ratified association agreements or bilateral agreements with the EU, or with the Republic of Cyprus , in the Public Contracts Sector “*
2. Submission via e-mail shall not be accepted. As per Section 3 clause 28 of the bidding documents, bids along with the bidders’ supporting documentation must be received by IOM at the address s 7 Megalou Alexandrou str., Argypoli 16452, Athens.

### Question 2:

- “We kindly ask you to:*
1. *Allow electronic bid submission (by email);*
  2. *Grant a 20-day postponement of the deadline, in consideration of the “magnitude”/complexity of the bid. This would allow both prospective bidders to prepare a comprehensive proposal and IOM to rely on a wide plurality of offers.*
  3. *Furthermore, please clarify how to obtain drawings of the Modular buildings (containers) to be supplied.”*

### Answer 2:

1. Submission via e-mail shall not be accepted. As per Section 3 clause 28 of the bidding documents, bids along with the bidders’ supporting documentation must be received by IOM at the address s
