

RENTING AN APARTMENT IN GREECE

WHAT DO I NEED TO RENT AN APARTMENT?

ΑΕΜ/ΑΦΜ

Where can I get my AFM?

In the **Tax Office** ($DOY/\Delta OY$) closest to where you live. Although no appointment is necessary, you should visit the tax office between 9am and 1pm – check the opening hours of each office prior to your visit.

What do I need to have with me?

- Residence Permit or stamped Full Registration
 Card
- **Proof of Address** (such as a utility bill or a solemn declaration by your host or landlord).

IMPORTANT!

Upon issuance of your AFM, you should ask for your key number ($Kleidarithmos/K\lambda\epsilon\iota\delta\acute{\alpha}\rho\iota\partial\mu\circ\varsigma$) which allows you to access **Taxisnet**, the official site of the Independent Authority for Public Revenue ($AADE/AA\Delta E$) where you can monitor all your tax-related activity, including tax declarations, lease agreements, etc.

If you reside in an open accommodation center, it is helpful in every interaction with public services or private service providers (i.e. banks) to have with you the *proof of residence certificate* or a proof of address if you resided in ESTIA accommodation.

What do I need to have with me?

- Residence Permit or stamped Full Registration
 Card and your passport, if you have one
- Copy of the document with your **AFM** number
- **Proof of address** (such as a utility bill or a solemn declaration by your host or landlord)
- A bill from your mobile company proving that your phone number is listed under your name or a certificate from your mobile company stating that your phone number is listed under your name
- If you are employed, evidence of your salary (either pay slips or a letter from your employer)
- If you are unemployed, a copy of your unemployment card from the Greek Manpower Office (OAED)
- Your tax clearance (ekkatharistiko eforias/εκκαθαριστικό εφορίας) or a solemn declaration that you have not submitted a tax declaration in Greece
- Your signed Declaration of participation in the HELIOS project

IMPORTANT!

Some banks might request a minimum deposit (i.e. 5-30€) to open a new account. The experience of opening a bank account in Greece varies from branch to branch.

FINDING AN APARTMENT

Where can I look for an apartment?

• Rental signs around the neighborhood(s)

ENOIKIAZETAI

- Online in the HELIOS dedicated website apartment pool, www.heliospiti.com (EN)
- Online in local sites, such as: xe.gr (available in English and Greek), spitogatos.gr (EN/GR), tospitimou.gr (EN/GR), spiti24.gr (EN/GR/AR/FR), spiti360.gr (EN/GR), plot.gr (EN/GR)
- Local and national newspapers feature a rental listing section (Ενοικιάζονται)
- Real estate agencies [they will charge a fee for their services - usually one month's rent value]
- Social media, such as Facebook Marketplace
- **Information** from friends, family, community

IMPORTANT!

Rental costs may vary depending on the city and area you are looking for a house and are usually more expensive in big city centers (such as Athens and Thessaloniki).

Households who share accommodation are advised to ensure that landlords indicate the maximum number of people who can reside in the accommodation, as well as to include all residents' names on the lease.

LEASING AN APARTMENT

What is a lease agreement? A lease agreement ($misthotirio/\mu\iota\sigma\vartheta\omega\tau\acute{\eta}\rho\iota o$) is a contract between all parties involved in the leasing of a house that includes their rights and obligations for the time period described in the agreement.

Make sure you have understood all the clauses of the lease agreement prior to signing it.

What happens after I sign a lease agreement?

After signing the hard copy of the lease agreement, you need to complete these steps:

STEP 1. Keep an original copy of the agreement

STEP 2. The landlord will upload the agreement on **Taxisnet**

STEP 3. You should sign into Taxisnet to accept the online lease agreement

STEP 4. Upon signing the hard copy of the lease agreement, you will be required to pay 1 or 2 months of rent in advance as a **security deposit**. The security deposit is returned at the end of the lease, if there are no damages or outstanding bills pending for the property.

IMPORTANT!

Clarify with the landlord the procedure to change the personal data on the utility bills.
