Established in 1951, IOM is the leading inter-governmental organization in the field of migration and works closely with governmental, intergovernmental and non-governmental partners. The International Organization for Migration (IOM) is committed to the principle that humane and orderly migration benefits migrants and society. As the leading international organization for migration, IOM acts with its partners in the international community to: assist in meeting the growing operational challenges of migration management; advance understanding of migration issues; encourage social and economic development through migration, and; uphold the human dignity and well-being of migrants.

In Greece, IOM is focusing on responding to the Mediterranean migrant's crisis, in support of the Greek Government and in cooperation with all other agencies involved. IOM currently implements interventions within the areas of emergency, preparedness and response, disaster risk reduction, livelihoods, healthcare and psychosocial assistance, assisted voluntary return of migrants, migration and development, resettlement and repatriation, family reunification, counter human trafficking, assistance to vulnerable migrants.

Internal and external candidates are eligible to apply to this vacancy. For the purpose of the vacancy, internal candidates are considered as first-tier candidates.

Context:

In close collaboration with national authorities and experienced Partners, through the HELIOS project IOM aims at promoting the integration of beneficiaries of international protection and temporary protection into the Greek society through the provision of integration courses, the support for independent living, including rental subsidies, activities for employability support, activities for the sensitization of the host community and integration monitoring.

Under the overall supervision of the Senior Project Coordinator and the direct supervision of the National Project Coordinator, the successful candidate will support project activities of the Integration component within the assigned area of responsibility.

Core Functions / Responsibilities:

1. Manage the Integration Monitoring Team by ensuring smooth coordination and promoting positive dynamics between staff.
2. Coordinate and monitor the implementation of project activities under the assigned component.
3. Organize the workload and provide guidance and instructions to the respective Project Assistants.

4. Create tools and procedures to ensure the provision of quality services and monitoring of project activities. Ensure the homogeneous provision of services through guidance and corrective measures, when needed.
5. Monitor the quality of services provided by Project Assistants, and by Implementing Partners as applicable, through physical verification and field visits. Report to the Coordination Team, as required.
6. Collaborate with other Project components by setting common goals, timely exchanging information and harmonizing standards and practices.
7. Coordinate, collaborate and ensure efficient communication with Implementing Partners as assigned. Liaise and coordinate with Implementing Partners to ensure timely and qualitative delivery of services, including information provision and logistical arrangements.
8. Ensure the collection of data and Means of Verification as well as the timely submission of reports and any other necessary information to the Project Coordination Team.
9. Continuously assess the needs of the project component and report to the management team in a timely and accurate manner, to ensure informed decision-making.
10. Ensure the implementation of standard operating procedures and project regulations, as developed in the framework of the project.
11. Represent the project in relevant meetings with the committees established by the Donor, other State and non-State Stakeholders and/or Working Groups.
12. Participate in drafting reports to the Donor, in a timely and efficient manner.
13. Perform other duties as may be assigned.

Required Qualifications and Experience

Education

- University degree in Business Administration, Education, Pedagogy, Social Sciences or a related field from an accredited academic institution with minimum four years of work experience.
- Master's degree in above fields is considered an advantage.

Experience and Skills

- Previous work experience in a similar role;
- Excellent communication and negotiation skills, personal commitment, efficiency and flexibility;
- Ability to work with minimal supervision; and,
- Excellent level of computer literacy.
- Demonstrated ability to work well under pressure and keep deadlines;
- Strong work ethics and commitment to humanitarian principles;
- Willingness to work under difficult conditions.

Fluency in **English** and **Greek** (written and oral) is required.
