This Addendum No. 1 is issued to amend information provided in the Bidding Documents and Instructions to Desludging Service Providers for the *“Establishment of a service agreement for the provision of Desludging Services in the Long Term Accommodation Centers in Elefsina, Malakasa, Oinofyta, Ritsona, Thiva, Thermopyles, Andravida, Korinthos and Kato Milia-Pierias for a period of one (1) year, with a possibility of one (1) year extension”* issued to the prospective service providers.

A) Invitation Letter: The clause “Proposals shall be delivered by hand or through mail courier to IOM with office address at 7, Megalou Alexandrou, 16452, Argyroupoli on or before **21st of June, 2021 at 12:00 hours**. No late proposal shall be accepted.” is replaced with the following:

B) Bidding Documents - Request for Proposal (page 4) : The clause “The Proposals shall be valid for a period of sixty (60) calendar days after the submission deadline and shall be delivered by hand or through mail courier to IOM with office address at 7, Megalou Alexandrou, 16452, Argyroupoli on or before **21st of June, 2021 at 12:00 hours**.” is replaced with the following:

C) Bidding Documents - Section I. Instructions to Desludging Service Providers / Clause 9.5 (page 12): The clause “Proposals must be received by IOM with office address at 7, Megalou Alexandrou, 16452, Argyroupoli on or before **21st of June 2021 at 12:00 hours**. Any Proposal submitted by the Service Provider after the deadline for receipt of Proposals

prescribed by IOM shall be declared “Late,” and shall not be accepted by the IOM and returned to the Desludging Service Provider unopened.” is replaced with the following:

“Proposals must be received by IOM with office address at 7, Megalou Alexandrou, 16452, Argyroupoli on or before **22nd of June 2021 at 12:00 hours**. Any Proposal submitted by the Service Provider after the deadline for receipt of Proposals prescribed by IOM shall be declared “Late,” and shall not be accepted by the IOM and returned to the Desludging Service Provider unopened..

All other terms and conditions of the Bidding Documents remain unchanged.
