“The Proposals must be delivered by hand or courier mail to IOM – Office in Greece at IOM office in Athens, 7, Megalou Alexandrou str., 164 52,

Argyroupoli, Greece **on or before 16th of June 2021, 14:00 local hrs.** Any Proposal submitted by the Service Provider after the deadline for receipt of Proposals prescribed by IOM shall be declared “Late,” and shall not be accepted by the IOM and returned to the Service Provider unopened.”

All other terms and conditions of the Bidding Documents remain unchanged.
