## **Addendum No 1 – Extension for Submission of Bids Supply and delivery of Modular Clinics**

IFB No.: 2021/MED/06/BR

This Addendum No. 1 is issued to amend information provided in the Bidding Documents and General Instructions to Bidders for the “**Supply and delivery of Modular Clinics**” issued to the prospective bidders. In detail:

### **Section B. The Bidding Documents**

#### **Clause 14 Documents Establishing Bidder’s Eligibility and Qualification**

##### **The subclause 14.1b has been added. In detail:**

*14.1b Bids submitted by a joint venture of two or more firms as partners shall comply with the following requirements:*

- a. the Bid shall include all the information listed in Sub-Clause 14.4 for each joint venture partner.*
- b. the Bid shall be signed so as to be legally binding on all partners.*
- c. Attach the Agreement among all partners of the joint venture (and which is legally binding on all partners), which shows that:*
  - all partners shall be jointly and severally liable for the execution of the Contract in accordance with the Contract terms.*
  - one of the partners will be nominated as being in charge, authorized to incur liabilities, and receive instructions for and on behalf of any and all partners of the joint venture; and*
  - the execution of the entire Contract, including payment, shall be done exclusively with the partner in charge.*
- d. The Bid Security of a joint venture must define as “bidder” all joint venture partners and list them in the following manner: a joint venture consisting of “\_\_\_\_\_,” “\_\_\_\_\_,” and “\_\_\_\_\_”.*

##### **The subclause 14.4 (n) has been added. In detail:**

- n) Joint venture agreement among all partners (in case of a joint venture) as stated in clause 14.1b.*

**All other terms and conditions of Clause 14. Documents Establishing Bidder’s Eligibility and Qualification remain unchanged.**

## **Extension for Submission of Bids**

In order to allow prospective bidders reasonable time in which to take the amendment into account in preparing their bidders, IOM is extending the deadline for the submission of bids. Bids must be received by IOM at the address specified under ITB Clause 19.2.a no later than **28 May 2021, 14:00 local hrs.**

### **Section D. Submission of Bids**

#### **Clause 20 Documents Establishing Bidder's Eligibility and Qualification**

*20.1 Bids must be received by IOM at the address specified under ITB Clause 19.2.a no later than 13 May 2021, 14:00 local hrs.*
