

WHAT FINANCIAL SUPPORT WILL I RECEIVE?

After entering into a lease agreement, each household will receive financial support according to the number of family members (see table). Rental subsidies consist of:

- An **initial disbursement** paid **only once** after you submit to the HELIOS staff all the required documentation listed below.
- A **standard amount** paid on a **monthly** basis after the submission of the proof of the payment of your rent.

HOW CAN I RECEIVE THE INITIAL DISBURSEMENT?

Which documents should I provide to the HELIOS team?

- Copies of all family members' Identification Documents
- TaxisNet printout after signing electronically the lease agreement
- Proof of your IBAN account
- Proof of the IBAN account of your landlord

Where should I present the documentation?

You must submit the documentation **in person** to the HELIOS staff either during teams' visits to Open Accommodation Centers or FILOXENIA Hotels either at the Integration Learning Center closest to where you live.

What if I cannot reach the ILCs?

If you reside in a remote area and you have no access to the ILCs, you can send all the required documents via email at iom_helios_info@iom.int

HOW CAN I RECEIVE THE MONTHLY DISBURSEMENT?

Which documents should I provide to the HELIOS team?

To receive your monthly rental subsidies, you are required to submit to the HELIOS staff a bank receipt as a proof of payment of your rent.

Where should I present the documentation?

You must submit your monthly payment receipts **in person** to the designated HELIOS Staff at the ILC closest to where you have rented your apartment or where you attend your integration courses.

What if I cannot reach the ILCs?

Only in **exceptional** cases, if you cannot visit one of our centers, you can contact us for instructions at the WHATSAPP numbers in the bottom left of this page.

IMPORTANT! The latest, as soon as you receive the first payment, you **must** leave your current accommodation place and move into the apartment you have rented under HELIOS project.

ATTENTION! Payments to apartments' owners in cash are NOT accepted.
